


GETTING STARTED:

Thank you for purchasing the Otava Beamformer Eval Kit. Follow these steps to connect the OTBF103-EVAL card to the MicroZed development board and get started with the GUI.

- Connect the two Samtec cables between the I/O Carrier Card and the OTBF103-EVAL card as shown in the picture
- 2. Program the uSD card and place it in the MicroZed SOM
- 3. Plug the USB (and Ethernet) cables into your host PC
- Go to avnet.me/OTAVABFIC-KIT, download the Getting Started Guide and follow the instructions for setting up the board, downloading the uSD card image and installing the Windows executable.
- Plug the MicroZed SOM into the I/O Carrier Card and move the power switch, SW5, to the ON position
